

# Why join AIC as a Full Member?

The Agricultural Industries Confederation (AIC) is the UK's lead trade association for the agricultural supply industry and represents businesses in key sectors within the supply chains that feed the nation. Formed in October 2003 by a merger of three trade associations, today AIC has over 230 Members in the agri-supply trade and represents £17.8 billion turnover at farmgate.









AIC works on behalf of its Members by lobbying policymakers and stakeholders, delivering information, providing trade assurance schemes, and offering technical support.

Full Membership is available to companies or organisations that are traders in, manufacturers, processors, distributors, brokers or agents of grain, pulse, protein and oilseed crops, forage additives, seeds, feeding stuffs, fertilisers, agricultural or horticultural chemicals or other goods or services used in agriculture. Other Memberships are available to companies, organisations or individuals operating in the wider agricultural supply industry which do not qualify for Full Membership.
